Privacy Policy for Exsion365

Exsion365 (referred to as "we," "us," or "our") is committed to protecting your privacy. This Privacy Policy explains how we collect, use, and share personal information from users ("you") of our website **Exsion365** ("the Website"). By accessing or using the Website, you agree to this Privacy Policy.

1. Information We Collect

We collect various types of information to provide and improve our services. The types of personal information we may collect include:

1.1. Personal Information Provided by You

- **Contact Information**: Name, email address, phone number, mailing address, or other contact details provided through forms or account registration.
- **Account Information**: Username, password, and any other information you provide when creating an account on the Website.
- **Transaction Information**: If you make a purchase or engage in financial transactions on the Website, we may collect billing and payment information, including credit card details.

1.2. Automatically Collected Information

When you visit or interact with the Website, we may automatically collect:

1.3. Information from Third Parties

We may receive information from third parties, including service providers and partners, to supplement the personal data we collect directly from you. This may include social media profiles or public data made available via third-party platforms.

2. How We Use Your Information

We use your personal information for various purposes, including:

- **Providing Services**: To operate, maintain, and improve the Website and deliver services you request, such as processing transactions.
- Customer Support: To respond to your inquiries and provide customer support.
- **Communications**: To send you notifications, updates, newsletters, or promotional materials (you may opt out of marketing communications at any time).
- **Security**: To protect the Website and users against fraudulent, illegal, or unauthorized activities.
- **Legal Obligations**: To comply with legal requirements, such as tax regulations, and enforce our Terms of Use.

3. How We Share Your Information

We may share your personal information with third parties under the following circumstances:

3.1. Service Providers

We may share your information with third-party service providers who assist in operating the Website, processing payments, delivering emails, or providing customer support. These providers are obligated to protect your data and use it only for the services they provide on our behalf.

3.2. Business Transfers

In the event of a merger, acquisition, or sale of all or a portion of our business, your information may be transferred as part of that transaction.

3.3. Legal Requirements

We may disclose your personal information to comply with legal obligations, enforce our agreements, or protect the rights, property, or safety of Exsion365, our users, or others.

3.4. With Your Consent

We may share your information with third parties for purposes not covered by this Privacy Policy if we obtain your explicit consent.

4. Data Retention

We retain your personal information only as long as necessary to fulfill the purposes for which it was collected, or as required by applicable laws and regulations. When we no longer need your data, we will securely delete or anonymize it.

5. Security

We take reasonable precautions to protect your personal information from unauthorized access, disclosure, or misuse. These measures include encryption, access controls, and regular security audits. However, no data transmission over the Internet or storage system can be guaranteed as 100% secure.

6. Your Data Protection Rights

Depending on your location and applicable laws, you may have certain rights regarding your personal information. These rights may include:

- Access: You may request access to the personal information we hold about you.
- **Correction**: You may request corrections to inaccurate or incomplete personal data.
- **Deletion**: You may request that we delete your personal information, subject to certain legal obligations.
- **Restriction**: You may request that we restrict how we process your data under certain circumstances.
- **Portability**: You may request that your personal information be transferred to you or a third party in a structured, commonly used format.
- **Objection**: You may object to the processing of your personal data for specific reasons, such as marketing.

You can manage your cookie preferences by adjusting your browser settings. However, disabling cookies may affect the functionality of the Website.

8. Children's Privacy

Our Website is not directed at children under the age of 16, and we do not knowingly collect personal information from children. If we become aware that we have inadvertently collected personal information from a child, we will delete it as soon as possible.

9. International Data Transfers
